2	<input type="radio"/> Missouri law permits the granting of a temporary license for private clinic practice.
3	<input checked="" type="radio"/> Missouri law requires osteopathic colleges to be accredited by the American Osteopathic Association or the American Medical Association. The curriculum of college health care programs must include training towards the degree of bachelor of arts or bachelor of science from an accredited college or university that is approved by Missouri law.
4	<input type="radio"/> Missouri law states that anyone who has been denied a license, permit or certificate to practice in another state shall automatically be denied a license to practice in this state.
5	<input type="radio"/> Patient records containing either the name, locality and control of the licensee shall be maintained by the licensee of the board or the licensee's designee. The records are to be kept until the date of the last professional service was provided.
6	<input type="radio"/> All professional licenses expire on January 31st of each year regardless of the date that the license is issued.
7	<input type="radio"/> Section 204.105 RSMo, provides the grounds for denial, suspension or revocation of a physician's license.
8	<input type="radio"/> Osteopathic colleges may no longer require a physician to receive a medical and osteopathy preliminary examination or supplementary treatment, diagnostic tests or medical or surgical services.
9	<input type="radio"/> Practice and supervision of medical diagnosis by the Board shall not be subject to an action for civil damages.
10	<input type="radio"/> A physician located outside of the state of Missouri shall not be required to obtain a license when the physician licensed in Missouri states, in writing, authority and responsibility for the diagnosis or diagnosis and treatment in the state of the patient located within this state.
11	<input type="radio"/> The Missouri Board of Healing Arts shall at least quarterly publish a list of all persons whose licenses have been suspended, revoked, annulled, renewed, denied or renewed.
12	<input type="radio"/> Missouri law requires that a physician notify the Board within fifteen days of any address change.
13	<input type="radio"/> A physician does not receive a notice to renew their registration, but the is exempt from paying the fee for the next year.
14	<input type="radio"/> Fees of any kind shall not be levied by the Board or its other members of any applicant.
15	<input type="radio"/> A license under this chapter shall in any other business card, advertisement, prescription blank, sign, or public listing or display of any nature whatsoever, display the degree in which holder is entitled by reason of their diploma.
16	<input type="radio"/> A physician's license may be dissolved for delegating professional responsibilities to a person who is not qualified by law, all conditions, and requirements to license holder's own responsibilities.
